Registration Fee (K-8, returning family)	\$ 150 per child – due at registration
Registration Fee (K-8, New family)	\$ 250 per child – due at registration

Registration Fee (Pre-K)	\$ 125 per child – due by February 28, 2011 or at the time of registration.

Tuition Payment Options:

Tuition can be paid by one of two payment methods.

- In full by August 1, 2011; a 3% discount will apply.
- Monthly from August through May. Payments are due on the 1st of every month.

Registration Dates: Current School Families: Registration Begins February
 Open Registration: Registration Begins March 1

Current families registration is due by February 21, 2011. **Any current family registering after this date will be charged open registration rates.**

Parish Rate: Given to families that are registered at St. Patrick Catholic Church. This rate is also offered to contributing families of our feeder parishes and to families that move to our Community from parishes outside of Pinellas County.

Non-Parish Rate: Given to all non-Catholic or non-parish families.

Late fee: A \$25 late fee is charged to accounts not paid by the 10th of each month.

Returned Check Fee: A fee of \$25 will be charged for all returned checks or accounts with insufficient funds.

Delinquent Accounts: Registration papers will not be processed for families with delinquent accounts until accounts have been brought up to date.
